

**GEORGIA DISTRICT PILOT INTERNATIONAL**  
**EDWINA GILL GROWTH AWARD 2023-24**

The Edwina Gill Growth Award, honoring Past Georgia District Governor Edwina Gill, shall be presented each year to the individual Pilot Club who has the largest percentage of membership growth from February 1, 2023, to January 31, 2024.

**Criteria for outstanding growth are:**

- the largest percentage of increase in membership for the period
- the largest percentage of retained members for the period

Award will be determined from **Notification of Change in Membership Information** reports filed by the Club Recording Secretary, **along with** the submission of the entry form with each months totals.

**Note:** Club must include all notification of change in membership information that was done over the time frame indicated (February 1, 2023, to January 31, 2024).

Percentage of increase must be greater than fifteen (15) percent of last year’s membership average.
